Dear Brothers and Sisters,

he outlook for 2018 is looking to mirror 2017 once we get through this rain and snow period. Downtown Sacramento will continue to be a hotbed of construction activity. Pipelayers are at a premium, striping contractors are looking for more hands with Class A Licenses and every other week it seems we're doing pre-jobs for PG&E Projects. The SB 1 (gas tax) funding will be kicking in by April and May and these road and bridge projects will be springing up throughout California.

Local 185 members need to be ready to go to work when called.

If you accept a dispatch to a contractor, it's your responsibility to get to work. By not showing up, it only gives the contractor ammunition to have another craft do our work. Virtually all our signatory contractors drug test and by not complying with a contractor's drug policy, or not showing up after you were dispatched, it hurts your reputation and Local 185's. We need you on these projects. With the work forecast for 2018, our Representatives need your "Eyes and Ears" on these projects to protect our jurisdiction with phone calls to our office. As diverse as the Laborers jurisdiction is, we are being attacked by most of the crafts in the Building Trades. To protect our work, we must be at every pre-job meeting, every mark-up meeting and every prebid meeting, otherwise we will lose the work.

One sure way to protect our work is to be the best trained work force anywhere. Sign up at the Hall for certifications, re-certifications and Class A Licenses. All are necessary if we're to maintain our high standards with contractors. We do most Saturday and Sunday training at 185 so you won't be losing work Monday through Friday. Take advantage of this

Queridos Hermanos y Hermanas,

El pronóstico para el 2018 parece reflejar el 2017, una vez que pasemos por este periodo de lluvia y nieve. El centro de Sacramento continuará siendo un hervidero de actividad de construcción. Los colocadores de tuberias escasean, los contratistas de las compañías encargadas de pintar las líneas de tránsito están buscando más gente con licencias Clase A, y parece que semana por medio estamos haciendo pre-trabajos para provectos de PG&E. La financiación de SB 1 (impuesto al gas) estará entrando en efecto en abril y mayo, y estos proyectos de calles y puentes estarán brotando por todo el estado de California.

Greetings,

Welcome Brothers and Sisters to the 2018 season. I cover Yuba. Butte, Sutter, Colusa and Glenn counties. The last few rains have delayed the start but buckle your boots up, because here we go! Also, a big welcome to our new members, journeymen and apprentices, we had at least 1,000 new hires and that number keeps increasing. The Local 185 leadership welcomes you and wants you to enjoy a good wage, two, count them, two pensions, great health benefits and vacation pay, along with a voice on the job site. Make sure, if you ever get the chance, to thank the retirees and the past administrations for all the hard work they have done to create this.

The Business Manager and his team will go to any length to get you trained to get you on the job and stay on the job. We put on training almost every weekend at the 185 Sacramento Hall and I am absolutely sure if Doyle had an 8th day in the week, we would have some sort of training class at 185. Just last Saturday, we had to open the lobby for a classroom because 3 of the classes were already scheduled. These are contractor driven classes with PG&E OQ certs, pipe fusion, coating, signaling and rigging, high scaling, etc., so the door is open for success. But, YOU have got to put the work in.

As for the work picture, obviously we have Kiewit up at the dam with 60% of the work yet to be done. We also have Neil's Controlled Blasting, Penhall and Syblon Reid up there. Another nice project is the \$70 million 5th Street Bridge connecting Yuba City and Marysville. Up in Chico we have DPR that was just awarded the \$100 million Science Building at Chico State. Up HWY 70, in the little town of Belding, Stewart Engineering picked up a little bridge job. If you go further up HWY 70, Viking has got a couple of jobs going too. We also have West Valley and All-American Construction working throughout the mid-Valley area and Granite Construction in Strawberry Valley. As for the PG&E work, we have ARB, Barnard Pipeline, 3B Enterprises, Underground Construction and Teichert Pipelines who all have another full season of work in the 6 counties. If you have a decent License without any DUI's, the striping companies are always looking for good hands: Chrisp, Central Striping, Centerline Striping, Sierra Traffic Markings. And, of course, the flagging industry is clearly booming so, the same thing, clean DMV and no DUI's.

Job Issues – If you have any issues on the job, please call a Business Agent that covers that area ASAP. Do Not wait, we only have 10 days to file a grievance. If you are not getting your breaks or lunches, please don't wait until you quit or get laid off because it is a much tougher case as each day goes by. Also remember, if you don't feel comfortable signing anything the contractor gives you as in taking breaks or safety issues, do not sign them, talk to your Agent.

Remember, going home to your family in one piece should be your 1st priority.

Dignity as a Local 185 Laborer - Remember as a Laborer from Local 185, we expect you to show respect on and off the job site, and that means when you call or come in to the Local 185 office and talk to our Office Manager Susan and her awesome staff, Sarah, Bridget, Tanya and Ariana. Whether you think you are right or wrong, please show some respect. If you have to chew on anybody about any issue, please choose to bark at one of the Agents or Doyle, that's what we are here for. And remember, forgiveness is a strength.

It's time again, the work season is upon us. I am happy to inform you that Phase Two of the Echo Water Treatment Plant has been awarded to Balfour Beatty. For the Local Union, this is good news. This portion of the project will not be under a (PLA) Project Laborer Agreement. Balfour Beatty is one of our General Contractors that has worked with us in the past at the Vineyard Water Treatment Plant in Elk Grove, the Camanche Lake Water Treatment Plant and on the Galt Water and Sewer Treatment Plant. They have been very instrumental in the increase of local man hours and I expect this project will be the same. We do not have a pre-job date as of yet, but we should have a better view by the next Union meeting on May 10th, 2018.

As far as other projects in the South area; George Reed has started a nice micro-chip striping job in Galt, Condor Construction is still in Elk Grove working on the new Aquatic Center and there are a lot of small jobs in the surrounding area.

In closing, there has not been any new news on the Elk Grove Casino or Mall. As soon as we receive information, we will inform you at the Local Union meeting.

Dear Brothers and Sisters. As we are preparing to roll into the 2018 work season in the Northern California counties of Shasta, Trinity, Tehama, Siskiyou, Modoc and Lassen that is covered by the Redding Hall, it is going to be a busy season. We already kicked the season of with some of the following jobs. J.F. Shea has started off with the Klamath River bridge outside Yreka, another bridge is at the Weed airport exit. J.F. Shea has been awarded the South bound I-5 \$57,000,000 paving project from Mt Shasta to Lakehead. Tullis is working on Hwy 36 East in Red Bluff doing curb sidewalk and gutters, Tullis also has the I-5 repairs from Red Bluff to Corning, both jobs are majority night work. Tullis will be starting the Hwy 44 overpass between I-5 and Palo Cedro soon. Steelhead Construction was awarded a bridge project on Hwy 89 by McCloud. GSB will be continuing with the Shasta Viaduct bridge hopefully soon. Overaa Construction is working on the Shasta Lake

City waste water treatment plant. Central Striping will be restriping new industry regulation stripes starting with I-5 Oregon down to Red Bluff. There are other projects that are in the forecast, it will be a busy year!

Look at your certifications make sure they are up to date! Get the training you need so you are qualified for these upcoming jobs. We've had a lot of training classes thru the winter that had extra space. Check with the hall to find out when the upcoming classes are so you can be qualified to take that next job dispatch. Update your Q cards and be ready to go out to those upcoming jobs. Remember that dispatch is from 6:30 am to 9:00 am. Be by your phone and ready to go to work, if you are on the out of work list. Mark your calendars for Roll Call. Roll Call is the 1st Thursday of every month between 9:00 am and 12:00 pm.

SB1 Gas tax creates a lot of good jobs for our members. This is monies designated to transportation projects, which in turn is jobs for our members. "DON'T SIGN THE REPEAL SB1 PETITION IN FRONT OF THE STORES"! We need these jobs in the North state. In Closing, office hours are from 6:30 am - 9:00 am M - F in theRedding office. If you are planning to stop by. I advise you to call first. You can still use the Redding phone number (530) 221-0961 if no one is available, it will transfer to the Sacramento office after 3 rings.
